

## Contract Agreement (Form e-PG3 -10)

THIS AGREEMENT made the 17<sup>th</sup> day of October 2024 between Bangladesh Telecommunications Company Limited, Telejogajog Bhaban, 37/E, Eskaton Garden, Dhaka-1000 (hereinafter called "the PE") of the one part and Telcobright Limited, Venus Complex, 5<sup>th</sup> Floor, Kha-199/3&4, Pragati Sarani, South Badda, Dhaka-1212, (hereinafter called "the Supplier") of the other part:

WHEREAS the PE invited Tenders for certain goods and related services, viz, "Supply, Installation, Testing and Commissioning of SIGTRAN SMS Platform for BTCL on Turn key Basis (e-GP ID 997573)" and has accepted a Tender by the Supplier for the supply of those goods and related services in the sum of Taka 59,90,250.033 (**Taka Fifty Nine Lakh Ninety Thousand Two hundred and Fifty point Zero Three Three only**) including all kinds of VAT and Taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract hereafter referred to.
2. The following documents forming the Contract shall be in the following order of precedence, namely :
  - (a) the signed Form of Contract Agreement;
  - (b) the Notification of Award
  - (c) The Tender and the appendices to the Tender
  - (d) Particular Conditions of Contract;
  - (e) General Conditions of Contract;
  - (f) Technical Specifications;
  - (g) Drawings;
  - (h) Price Schedules and Schedule of Requirements and;
  - (i) other document including correspondences listed in the PCC forming part of the Contract
3. In consideration of the payments to be made by the PE to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the PE to provide the goods and related services and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The PE hereby covenants to pay the Supplier in consideration of the provision of the goods and related services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of Bangladesh on the day, month and year first written above.




